223. APOLOGIES FOR ABSENCE

224. MINUTES

RESOLVED: That the Minutes of the meeting held on 12th January 2021 be approved and signed by the Chairman when able to do so.

225. MEMBERS' INTERESTS

None declared.

226. POLICING AND COMMUNITY WARDEN REPORT

Community Warden Karl Aylett reported as follows:

- January was a quiet month.
- Job role is somewhat stifled as the usual duties undertaken are limited by Covid restrictions.
- Limited calls to the skatepark for a persistent number of older youths who believe that the current rules and restrictions do not apply to them.
- Dealt with a hoarding issue alongside Kent Fire & Rescue and also assisted a housing association dealing with a neighbourhood dispute.

Cllr Crow-Brown asked whether Karl had been made aware of some recent abuse suffered by his neighbours over access to a caravan.

Cllr Crow-Brown also commented that he had received reports of hare-coursing on the marshes. Karl responded that both he and PCSO Adrian Butterworth have been made aware of this.

PCSO Adrian Butterworth was not present.

227. COUNTY COUNCILLOR & DISTRICT COUNCILLORS REPORTS

Cllr Pugh reported as follows;

• TDC may offer a loan of between £700K-£1.5M to Your Leisure to keep the company afloat as they are experiencing financial struggles due to Covid.

- There are proposed changes to planning rules, including a possible charge being made for the submission of paper copy representations from consultees and the abolition of displaying yellow planning notices at sites for which a planning application has been received. A public consultation will be held.
- Complaints have been received about light pollution from Thanet Earth. Any complaints that we may receive can be forwarded to him.

Cllr Quittenden asked if the May elections are expected to go ahead as planned. Cllr Pugh responded that they may be delayed until September 2021.

228. CHAIRMAN'S ANNOUNCEMENT

Cllr. Mrs Gimes reported that both Clerks and the pitch caretaker are to be placed temporarily on flexible furlough, working reduced hours due to the current reduction in workload as a result of the pandemic.

229. REPORT OF THE CLERK

The Clerk reported that following the Council meeting in February, a quotation of £221 + VAT has been received and accepted for the annual service of St Marys Church clock. The census will take place on 21st March 2021.

The Clerk reported that the yellow lines have passed their consultation period and awaiting installation.

The Clerk reported that Andreea Plant (TDC) had advised that their solicitor was waiting for a response from our Solicitor with regards to completion of the asset-transfer. This has been followed up and our Solicitor will now respond.

The Clerk reported that due to the difficulties during the pandemic, Kim Dolman has taken the decision to permanently close the pre-school on 10th February 2021.

237. SKATEPARK ANTI-SOCIAL BEHAVIOUR

The skatepark remains closed in line with current Government restrictions.

The Chairman reported that an email has been received from TW Services confirming that the installation of the bund is likely to take place in March or April when the weather is drier.

Cllr Torbett confirmed that he has received email confirmation of the financial contribution for planting and landscaping from Sunningdale and he will forward this to the Clerk.

Cllr Day asked whether any of the persistent offenders who continue to use the skatepark despite its closure, have received fines. Community Warden Karl responded that this was unlikely but that PCSO Adrian Butterworth would be able to confirm this.

Cllr Quittenden explained that he had moved on an articulated lorry that had parked in the High Street car-park at the weekend.

Cllr Quittenden reported that the Non-Domestic Rating (Public Lavatories) Bill had its second hearing in the House of Lords and is now at Committee Stage.

Cllr Quittenden reported that there may be some areas in the High Street car park, garden section that may be suitable for wildflower planting, upon the completion of the asset transfer. Cllr Pugh agreed to assist with chasing the asset transfer to completion.
