No apologies were received.

83. ELECTION OF CHAIRMAN

RESOLVED: That Cllr. Quittenden be elected Chairman of the Committee for the year 2017/18.

84. APPOINTMENT OF VICE CHAIRMAN

Cllr. Day was appointed Vice Chairman of the Committee for the year 2017/18.

85. MINUTES

RESOLVED: That the Minutes of the meeting held on 19th October 2016 be approved and signed by the Chairman.

86. DECLARATIONS OF INTEREST

No declarations of interest were made.

87. H2B FUNDING – SECTION 106 WORKS

The Clerk reported upon the following:-

- i) Review projects completed and costs James Wraight (Kent Highways) had been asked to provide detailed costings and these would be reported to Committee once received. However it appeared that £100,000.00 was still available depending on the figures provided by James.
- ii) Laundry Road Lay-by The Clerk reported that she had now received the deed of dedication from the landowners.
- iii) Additional Yellow lines These works would be done separately by Kent Highways as TDC do not have the staffing resources to draw up the plans. Members noted that TDC had applied to lay down additional yellow lines at the junction of Monkton Road/Taylor Road and also in St. Mary's Road.
- iv) Extra works at Butts Field Estate programmed for summer 2017 These works were scheduled to be undertaken during the school holiday together with the erection of an additional barrier at the new school pedestrian exit.
- v) Change speed limit from 50mph to 30mph from the roundabout to existing 30mph in Tothill Street Members were asked to consider further suggestions to undertake works to use the additional 106 funds.
- vi) Village gateway a meeting would be arranged with James Wraight (Kent Highways) to draw up proposals for Members further consideration; and
- vii) Bus shelter at the junction of Freemans and Monkton Road Cllr Quittenden agreed to speak to the residents of both houses in Monkton Road to seek consent for a shelter to be erected before further enquiries are made with Kent highways.
- viii) Improving traffic calming at Minster roundabout consider the options at a meeting with James Wraight.
